A non-ionic surfactant for use with glyphosate and certain brush weed herbicides to improve coverage, penetration and uptake on brush and woody weeds and ryegrass. Also for use with fungicides, insecticides, miticides and foliar micronutrients as per the directions for use table.

GENERAL INSTRUCTIONS

F.S.A. Penetrant Wetter and Sticker is a highly penetrating product suitable for use with glyphosate herbicides, certain brush herbicides, fungicides, insecticide, miticides and foliar nutrients.

It improves efficiency by enhancing the penetration and uptake into certain hard to control woody weeds such as bracken, gorse and perennial ryegrass.

F.S.A. Penetrant Wetter and Sticker is not a general-purpose surfactant and should only be used where addition of a silicone surfactant is recommended.

MIXING INSTRUCTIONS

Add F.S.A. Penetrant Wetter and Sticker to spray tank after the agricultural chemical is thoroughly mixed.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

DO NOT contaminate streams, rivers or watercourses with chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN.

Store in the closed, original container in a cool, well ventilated area. Do not store for prolonged periods in direct sunlight.

Triple-rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point.

If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.
